## **Late-Breaking Tax Measure Allows IRA Year-End Donations Until January 31<sup>st</sup>**

A key charitable tax break measure took effect December 17<sup>th</sup>, allowing people age 70½ or older to make tax-free 2010 year-end charitable gifts of up to \$100,000 from their IRA accounts up until January 31<sup>st</sup>, 2011. Congress granted the extension because the measure, in effect since 2006, wasn't renewed for 2010 and beyond until so late in the year. 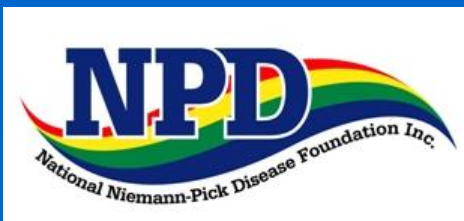
